
ACTS Online Payment Registration Procedure

4. Scan the BIR Form 2303 of the company indicated in your registration form. Upload the copy in the BIR Form 2303 and Other Requirements fields.

*Only the ICTSI Client Registration Form and the BIR Form 2303 are needed to complete your registration. Other documents are supplementary and will not hold your registration.

- 5. Once all fields are filled out and all necessary forms are uploaded, click "Register".
- 6. A notification will be sent to the email address inputted in the form to inform whether your application has been approved or rejected. If approved, this will include your log-in credentials. If rejected, the next steps will instructed.
