To avoid having your truck reverse during their gate out process, please be reminded to ensure that any X-ray, DEA, and/or BOC hold, if there are any, are already <u>lifted</u> before proceeding for exit. We also highly encourage everyone to make sure that storage and reefer charges are <u>paid and valid until the expected day of pull out</u> as lack of updated payment results in truck reversal during your exit as well.

Please note that the reversals upon gate out affect the gate out time of other trucks who have ensured complete requirements for their terminal exit. We would highly appreciate everyone's cooperation to lessen these increasing scenarios at our exit gate.

Kindly share with your team for everyone's proper guidance.
