

# TRUCK MANIFESTING

## FEATURE UPDATES

### OLD VERSION

Power Paid Thru (PPT) Validity should be at least 2 hours more than your selected appointment time.

Users are given an OK status upon Manifest submission which can then change to ERROR after a few minutes once system validation is completed.

Visibility on Truck Sharing is not completely available in the system.

Pick Up and Drop Off containers for double transaction can be manifested together if their bookings are of the same zone.

Drivers need to coordinate with their trucking companies or go to BOC satellite office to confirm XRAY/DEA hold lifting.

### UPDATED FEATURES

#### Power Paid Thru Adjustments

Users can now manifest a reefer booking whose zone is the same as the end of its PPT validity. Note, however, that any arrival after the start of the zone and expiration of PPT validity will require payment revalidation before exit.

#### Pending Confirmation Status

A **Pending Confirmation** status can now be seen after Manifest submission to indicate that their submitted details are still undergoing system validation. An OK or ERROR status will then be given after system has completed its checking.

#### Truck Sharing Feature

A truck can be shared between different users as long as the zones of the bookings that will be manifested together are not more than +/- 1 hour of each other.

#### Manifesting of 1-hr Adjacent Zones

Users can now manifest bookings that have matching zones or are not more than +/- 1 hour of each other.

#### SMS Notification for XRAY and DEA Hold Lifting

Drivers now receive an SMS notification once their XRAY and DEA holds are lifted which helps to remotely and immediately inform that they are cleared for exit.
